ADOPT-A-ROADWAY AGREEMENT

A. PROGRAM GUIDELINES:

All proposed participants must present to the Board of Aldermen their business, organization, family or individual names as it will appear on the signage. If approved, the Board will pass a Resolution approving the participation and erect appropriate designation and recognition signage.

The minimum roadway length which may be adopted is one-half (1/2) mile, which may be in the form of one-half (1/2) mile in length on one side of a roadway, or both sides of a roadway for a distance of one-fourth (1/4) of a mile equaling a total distance of one-half (1/2) mile. The minimum term of commitment is one (1) year.

The City will provide an adequate number of trash bags and a reasonable number of safety vests to the program participant.

The participant shall contact the City and advise when they will be working in their area and when the filled trash bags will be ready for pickup.

The City will collect the filled trash bags on the next available work day during normal work hours after the date of pickup.

The project representative shall hold a program guideline and safety informational meeting prior to each cycle of work.

Violations of these rules or of verified complaints may result in a warning being issued if minor in nature, and authority may be rescinded in the event of major violations or repeat or persistent minor violations at the City Administrator's discretion.

The City of Eureka assumes no responsibility or liability by means of sponsoring this Adopt-A-Roadway program. The City further in no way accepts or acknowledges any form of negligence, obligation or wrongdoing with regard to any incidents, accidents, injuries or damages arising out of direct or indirect actions of any Adopt-A-Roadway participant.

The City reserves the right to decline granting program participation authority to any applicant.

The City reserves the right to discontinue this program at any time.

This agreement shall remain in effect until either or both parties notifies the other of its termination.

B. SAFETY PRECAUTIONS AND OPERATIONAL REQUIREMENTS:

Think safety at all times. Safety is of the utmost importance, both to participants and roadway users.

Provide adequate adult supervision at all times.

Face oncoming traffic.

Wear appropriate and adequate clothing of light or bright colors which sufficiently cover and protect, appropriate shoes, and have gloves handy for broken glass, rusty and messy material pickup.

Have a First Aid kit, drinking water and transportation readily available and a communication device such as a cellular telephone.

Wear safety vests, a number of which will be provided by the City.

Stay clear of traffic lanes at all times and do not block shoulders or private driveway access.

Stop work in inclement weather.

Avoid active and disrupted construction areas.

Watch footing, and be alert for holes, obstacles, wet and slick spots.

Use special care when storing, handling and using tools.

Be alert for snakes and stinging insects.

Do not destroy or disturb public or private property in any way.

Do not trespass upon any private property.

Do not be loud or otherwise disruptive or offensive.

Do not distract motorists in any manner.

Please identify the roadway proposed for adoption below. If you are proposing to adopt a portion of a roadway, include a description by location (i.e. addresses) and distance. Additionally, indicate whether you are proposing to maintain one or both sides of the roadway or portion thereof.
